Background: Chapter 13 debtor who, having recently obtained discharge of her debts in Chapter 7, was ineligible for Chapter 13 discharge brought adversary proceeding for determination that junior mortgage lien was entirely unsupported by any equity in residential property that it encumbered and for entry of order stripping off lien. The Bankruptcy Court, Pamela Pepper, J., granted motion to dismiss, on theory that there could be no strip off in a no-discharge Chapter 13 case, and debtor appealed.

Holdings: The District Court, Rudolph T. Randa, J., held that:  
(1) debtor's ability to use her plan in order to "strip off" wholly unsecured junior mortgage lien was not conditioned on her eligibility for discharge, and  
(2) bankruptcy statute requiring, as prerequisite to confirmation of Chapter 13 plan without secured creditor's consent and without surrender of collateral securing creditor's claim, that creditor must retain its lien until payment in full or discharge, was applicable only to secured creditors, and not to junior mortgagee whose lien was entirely unsupported by any equity in mortgaged property.

Reversed and remanded.


